Update on On-going Follow-up of Report Recommendations©

September 16, 2015



#### Introduction

- ➤ To date, the OAG has published 33 reports containing 600 recommendations. Given the volume of reports and large number of recommendations, a follow-up process was developed.
- ➤ January 2015, the OAG began to cycle back on published recommendations and provide a risk ranking for each.
- ➤ Currently, 32 of 33 report risk rankings have been published on the OAG recommendation dashboard. The risk ranking associated with the Building Standards review will be published to the OAG dashboard later today.
- ➤ Beginning with the Fuel Spill report, the OAG began to provide a risk ranking with the release of each report.



# Process Updates

- The OAG has discussed the go-forward process in depth with the Chief Administrative Officer and provided details around what the OAG would expect from Management during the follow-up process.
- As part of the process, the AG and CAO have committed to work together with regards to the following:
  - CAO receiving three weeks to review the draft report and to provide response to the report recommendations prior to being presented to Audit and Finance Standing Committee
  - OAG to work closely with the Audit Coordinator to obtain all
    Management self-assessments which have been completed to date
  - AG will obtain all necessary information from the Audit Coordinator to satisfy report recommendations as well as obtain business unit contacts for additional questions/comments.



#### **Current Status**

- ➤ The OAG is pleased with the tremendous cooperation and assistance received to date during the process of gathering Management's self-assessments.
- ➤ The OAG, through meetings and correspondence with the Audit Coordinator, reviewed Management self-assessments and obtained corresponding business unit contacts for 13 of 33 OAG reports, accounting for 274 of 600 recommendations.
- As the OAG continues to receive information to support the recommendation status given by Management, follow-up will be completed as deemed appropriate by the OAG to verify the implementation status of each recommendation.

# October, 2015 Status Update

Currently, all 33 report risk rankings have been published on the OAG recommendation dashboard.

➤ The OAG, through meetings and correspondence with the Audit Coordinator, obtained and then reviewed Management selfassessments (including corresponding business unit contacts) for 28 of 33 OAG reports, accounting for 505 of 600 recommendations.

➤ We are now working through our standard process to determine the status of each of the recommendations.



### October, 2015 Status Update cont.

➤ We have discussed with the CAO a process to address any circumstances where our assessment of a recommendation status may differ from that of the Administration.

The committed goal of the AG and CAO is to ensure differences of opinion as to the recommendation status (in particular where probability and/or impact are high (i.e. risk is assessed as red)) are quickly addressed and a go-forward plan is identified.
